A HELPING HAND - Creating your own CUSTOMS DECLARATION

HOW TO CLEAR CUSTOMS WITHOUT DELAY

When it is necessary to supply a Customs Declaration?

Whenever a non-document is sent overseas it is necessary to complete a Customs Declaration. Non-documents are all commodities which requires a formal customs entry in the country of destination. If you are unsure whether it is necessary you should call our Customer Service Hotline for advice on 3252 411.

Why is it necessary to complete a Customs Declaration?

A properly completed Customs Declaration helps speed your consignment and helps your customer avoid unnecessary delays in Customs. Remember the value declared on the consignment should be the REAL value (even gifts or samples) as Customs may seize the consignment if it is under-valued. Please note Customs Authorities will not accept No commercial value. *

How to complete a Customs Declaration:

Your Customs Declaration must be completed on your company letterhead with three (3) copies attached.

- A Sender's name.
- B Sender's company and Address details.
- C Receiver's name.
- D Receiver's company and address details.
- E Package details.
- F Number of items (bags/boxes) travelling under the consignment note.
- G Consignment note number
- H A brief description of Reason for sending.
- I Date
- J Sender's name.
- K Sender's signature
